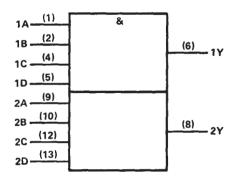





SN54LS21 . . . J OR W PACKAGE SN74LS21 . . . D OR N PACKAGE (TOP VIEW)




SN54LS21 . . . FK PACKAGE (TOP VIEW)



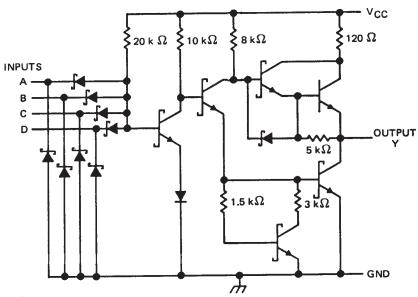
